That is a violation of our fire permit. If you need a stand or small side table for POS equipment, that is permitted. Just email me in advance or make a note on your contract.

• Each vendor may rent up to 24 feet (Four 6' tables or three 8' tables.)

• Vendors are allowed to have one free helper, and a second helper for \$5 if needed. No one should need a fourth or fifth person.

• There is a \$30 charge for returned checks.

• Cancellation policy: No refunds will be given. If you must cancel, your money will be credited to the following show. Cancellations after 9/27/2024 will not be credited.

- Setup begins at 7:30am Sunday morning.
- Please arrive by 10am. Arrivals after 10am will forfeit table.
- Show opens to public at 11am.
- No smoking is allowed in the exhibit hall. No pets are allowed, except for service animals. Please note on your contract if you will have a service animal.
- Hotel will supply BLACK table covers.
- Parking during the day is free. Overnight guests are charged \$16 to park overnight.
- Vendors are responsible for insuring their merchandise. Queens of the Doll Aisle is not responsible for theft or damage that occurs
